



**Advisory note, article 13 Regulation EU 2016/679- GDPR**

***Advisory note concerning the processing of personal data collected from data subjects***

In compliance with that provided for by Regulation EU 2016/679 (the European Regulation concerning the protection of personal data), we hereby supply you with the due information regarding the processing of personal data provided.

This is an advisory note that is provided pursuant to article 13 of Regulation EU 2016/679 (the European Regulation concerning the protection of personal data) and is also based on that provided for by Directive 2002/58/EC, as updated by Directive 2009/136/EC, regarding cookies as well as that provided for by the Regulations from the Italian Data Protection Authority (*Garante per la protezione dei dati personali*) dated 08.05.2014 regarding cookies.

**1. THE SUBJECTS OF THE PROCESSING**

**2. THE PURPOSES OF AND THE LEGAL BASIS FOR THE PROCESSING**

In addition, we inform you that we consider consent to have been expressed when you supply your data to other entities who collaborate with Scab Giardino S.p.a. for the same purposes or that replace Scab Giardino S.p.a. in managing the site <http://www.scabdesign.com>.

The data obtained is needed for, pertinent to and not excessive given the determined, explicit and legitimate scope, purposes and services of Scab Giardino S.p.a.

Parties belonging to the categories above perform their function(s) as Data Processors or operate in complete autonomy as distinct Data Controllers.

#### **4. TRANSFERRING DATA TO A THIRD COUNTRY AND/OR AN INTERNATIONAL ORGANISATION**

Supplied personal data, **will not be transferred** within or outside of the European Union.

#### **5. CONSERVATION PERIOD OR CRITERIA**

Processing will be done in an automated and/or manual way, with means and tools designed to guarantee the maximum security and confidentiality, by parties specifically appointed to do so.

In compliance with that provided for by article 5(1)(e) of Regulation EU 2016/679 personal data collected will be conserved in a form that allows the identification of the data subject for a period of time no greater than twelve months from the data subject being inactive, having achieved the purposes for which the personal data has been processed. #### **6. CONFERRING DATA AND REFUSING TO CONFER DATA**

## **7. THE RIGHTS OF THE DATA SUBJECT**

You have the right, at any time, to ask the Data Controller for access to your personal data, to have your data rectified, deleted and the processing of it restricted.

Furthermore, you have the right, at any moment, to oppose the processing of your data (including automated processing, for example, profiling) as well as restricting the portability of your data.

Without prejudice to any other administrative or judicial appeal, if you consider that the processing of data that concerns you has violated that provided for by Regulation EU 2016/679, pursuant to article 15(f) of the aforementioned Regulation EU 2016/679, you have the right to lodge a complaint with the Italian Data Protection Authority (*Garante per la protezione dei dati personali*) and, with reference to article 6(1)(a) and article 9(2)(a), you have the right to revoke, at any time, any consent previously given.

In the event of a request regarding data portability, the Data Controller will provide the personal data that concerns you in a structured, widely used and legible format, on an automatic device, without prejudice to paragraphs 3 and 4 of article 20 of Regulation EU 2016/679.
